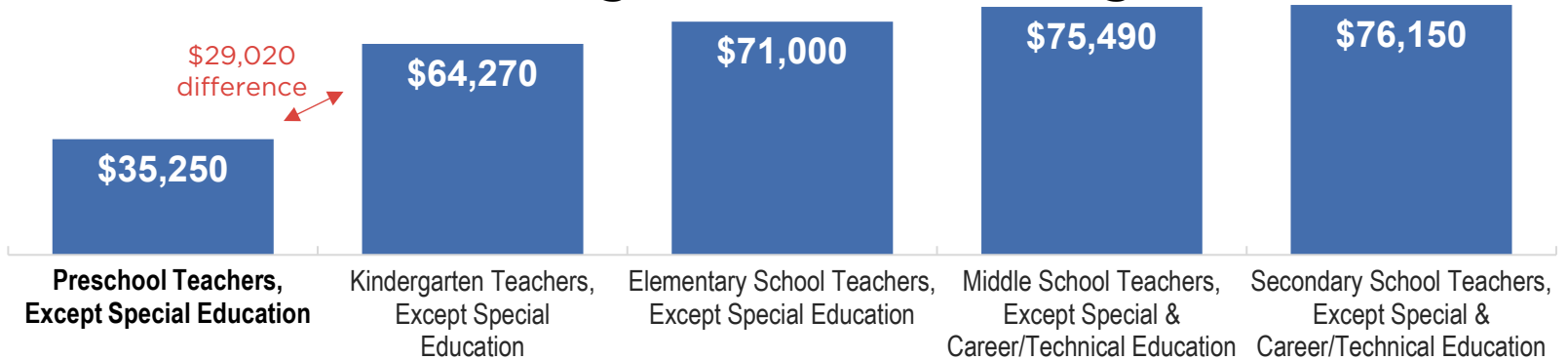


# HIGH-QUALITY, PUBLICLY FUNDED PRE-K Pennsylvania

## Low Wages = Teacher Shortage

\*Eligible children live in families earning up to 300% of FPIG (\$99,000 for a family of four). Children with access includes those enrolled in high-quality providers using public funds to support their pre-k education.

\*\*High-quality, publicly funded pre-k programs are offered through Head Start, Pre-K Counts, Philadelphia pre-k (PHLpreK), school district pre-k programs, and through child care provided in Keystone STAR 3-4 centers and group child care homes participating in the Child Care Works program for preschool-age children. Eligible providers include Head Start, Keystone STARS 3 and 4 center and group child care, PDE-licensed nursery schools and school districts.



*The Pre-K for PA vision is to ensure that all children can enter school ready to succeed by making high-quality pre-kindergarten accessible to every three- and four-year-old in Pennsylvania.*

Economic Policy Institute: The cost of child care in Pennsylvania

**To make meaningful progress toward families finding and affording high-quality child care and pre-k, Pennsylvania policymakers must:**

- Support the proposed investments in the early care and education workforce (at a minimum):
  - \$10M increase for the Child Care Staff Recruitment and Retention Program.
  - \$2M increase for the Head Start Supplemental Assistance Program.
  - \$7.5M increase for Pre-K Counts.
- Strengthen the child care sector:
  - Raise the child care subsidy income limit so more working families can get help paying for a child care program they trust.
  - Dedicate funds so child care and pre-k programs can better service children with special needs.
  - Advance targeted reforms that reduce unnecessary burdens on child care providers while preserving strong, enforceable health and safety standards that keep children safe.
